The theme of our first on campus, Pride of Providence, There's No Place Like Home, in many ways captures the collective feeling of our entire community. The ability to host our largest annual fundraiser in our own school home was just one of many firsts we experienced this year after moving to this amazing property in July of 2022.

Situated on a 21-acre campus, our new building can easily accommodate our anticipated growth in the coming years. With state-of-the-art classrooms and lab spaces, expansive fields, and regulation-size athletic facilities, we are confident that we now can fulfill the promise outlined in our 2026 Strategic Plan of becoming the school of first choice for the students we are lucky to serve.

In addition to this historical move, we achieved several incredible milestones this year:

- Significant progress on our \$15 million Capital Campaign, Achieving the Dream, which began in 2022 and soared to 80+% of our goal, reaching \$12 million at the end of 2023. The support of 63 families and organizations has empowered us to secure a new home worthy of our current and future students while ensuring we have the financial security to continue our mission.
- Enrollment grew from 196 students for the 22/23 school year to 237 this year.
- Growth in our number of Corporate Work Study Partners from 70+ to 114.





INSTITUTE FOR QUALITY EDUCATION - SCHOLARSHIP GRANTING ORGANIZATION (SGO)
